NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

1. OBJECTIVE AND PRINCIPLES

1. The objective of this MOU is to foster collaboration and to facilitate the exchange of knowledge based on reciprocity, best efforts, mutual benefits and frequent interactions.
2. This MOU will be carried out within the framework of the respective laws and regulations of the institutions and is intended to create legally binding rights or obligations.

2. SCOPE OF THE MOU

1. Both Parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge as well as faculty members in their research and consultancy. The work carried out by the First Party will also benefit the Second Party widening their understanding, perspectives, etc. The Scope of the MoU also includes the activities and projects relating to areas mentioned below:
 - Social Relevance project implementation for the benefit of students.
 - Providing exposure to students through internship opportunities.
 - Conducting Programs related to local community for Faculties, Students, Parents of PTVA's Institute of Management, and citizens of nearby localities.
 - Conducting activities related to nature conservation, local eco-tourism, socio-cultural aspects, and environment.
 - Organizing guest lectures through Society experts on Eco-tourism, environmental issues, societal issues, coastal tourism industry, blue economy etc. pertaining to local requirements.

3. GENERAL PROVISIONS

- II. The Party organizing an item of work shall have the nodal responsibility for mobilizing resources and the conduct of such works. There shall be exchange visits by faculty members and entrepreneurs for teaching, research, executive development and consultancy.
- III. Nothing in this understanding is intended to affect other cooperation or collaboration between the Parties.
- IV. All the collaboration activities according to this agreement shall be conducted following the laws and regulations governing both the parties.
- V. The First party shall conduct any lawful activity in the institute apart from the ones mentioned in the scope of this MoU (including arranging the Guest Sessions not listed as a part of this MoU) without consulting and/ or informing the Second Party.
- VI. This is a non-financial MoU signed by the Parties and neither Party is liable to pay any amount to the other Party for conducting any activity that falls within the scope of this MoU.

RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that **Parle Tilak Vidyalaya's Institute of Management**, and **Akhil Koli Samaj va Sanskruti Sanvardhan Sangh** are acting under this MoU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
