Student Admission and Support

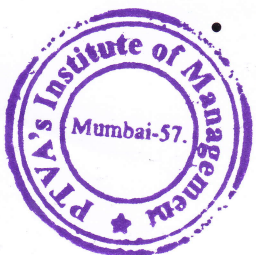
