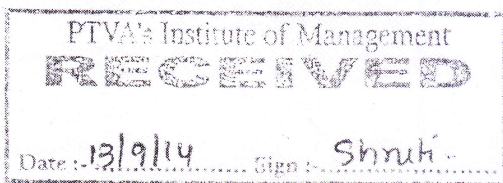



Respected Shri Anil Ganu Sir,


This is to bring to your kind attention that due to personal reason, I will not be in a position to continue my services with our esteemed institution.
