


## Minutes of the online IQAC meeting held online on October 24, 2020

- Minutes of the IQAC meeting held on May 15, 2020 were confirmed.
- Dr. (Smt.) Snehalata Deshmukh announced the major achievement of PTVAIM, its staff members and students including PTVAIM being appointed as the LEAD College by the University of Mumbai for conducting the MU Exam Mission 2020 with respect to post-graduate management institutions, PTVAIM's COEI's Institution's Innovation Council (IIC) getting 4.5 out of 5 stars awarded by the Ministry of Education, Government of India, CA Dr. Ajit Joshi being appointed as a member of Task Force for the implementation of National Education Policy (NEP) 2020 by the Government of Maharashtra, faculty members successfully completing the AICTE organized Workshop on "Universal Human Values", SWAYAM and NPTEL courses and our students securing highest marks at the University Level in examinations for consecutive two years.. She specifically congratulated the Director of PTVAIM, Dr. Harish Kumar S. Purohit and his team comprising of teaching and non-teaching staff members for their excellent performance during the lockdown period. She also congratulated Dr. Sucheta Pawar and her team of COEI comprising of Ms. Ridhima Mahabal and Ms. Siyara Pinto for their performance and well-organized activities throughout the last year.
- Dr. Purohit explained how the Institute is systematically planning the activities in accordance with proposed implementation of NEP 2020 and how successful completion of AICTE organized Workshop on Universal Human Values and other MOOC courses such as SWAYAM and NPTEL by the faculty members, were our baby-steps in this direction.
- Dr. Sucheta Pawar apprised the committee members about the activities done by COEI in the last quarter and how such activities are vital in COEI being selected as one of the "Top Performing IICs" in India.
- She also specifically mentioned the achievements of the COEI incubatees.
- She elaborated on the Project Saksham mentioning the work done under this project during the lockdown and future plans related to this project.
- She informed the meeting about 2 MoUs to be signed with Ghanashyamdas Saraf College and ICT.
- She also mentioned a possibility to enter into a MoU with LSF with respect to making Yuva of Gramin Bharat Atmanirbhar.
- She apprised the committee members about COEI's plan for the academic year 2020-21.
- She informed the members about the National Level Research Conference NCMAT 2021 that we are planning to organize jointly with Navinchandra Mehta Institute of Technology Development (NMITD) in association with the University of Mumbai in March 2021.
- It was suggested that Dr. Sucheta Pawar should engage with Mrs. Meenakshi Rao for the research work on Financial Literacy.
- Mr. Jigar Patel told the committee members that though MMS batch 2018-20 was one of the best prepared batches from the perspective of Placements, unfortunate scenario arising due to COVID 19 affected the placement prospects of this batch.

- He informed that despite bad placement scenario due to lockdown, PTVAIM could attract the organizations such as BYJU's, Deloitte, APEX, Capgemini, InSync analytics and ISS to hire its students.
- He also told the members that it was decided to extend the placement season for MMS batch 2018-20 upto November 2020.
- He said that he has personally started one-on-one interaction with the passing out the batch with respect to their placement prospects.
- He informed the meeting that placement cell of PTVAIM conducted an online session on "Job Market Post COVID 19" as suggested by the IQAC committee in the last meeting in order to have a connect with the participants of HR Conclave organized by PTVAIM in March 2020. The participants of this Conclave were invited as panellists for this online session on "Job Market Post COVID 19".
- It was suggested to him that he can probably organize an experience sharing session by the students who got placed during COVID 19 for the benefit of those who are yet to be placed.
- It was also suggested that till such time that these students get placed with some organization, they can be encouraged to take up the internship/project with the companies to sharpen their employability skills.
- Mr. Jigar Patel was advised to contact our alumni to find out the possibility of our students getting placed through their contacts by Diwali 2020.
- He was also advised to have a conversation with UPGRAD regarding a tie-up with them. UPGRAD is an online program leading to placements after 6 months training by them.
- It was suggested that next meeting onwards, the placement data should be presented stream-wise.
- It was unanimously decided to continue with the same committee members for the period of the next three years, except for the student representative.
- Mr. Jigar Patel apprised the committee members about the "Cyber Safety Awareness Campaign" that PTVAIM is planning to organize in association with the Mumbai Cyber Crime Branch and Responsible Netism, as a part of Centenary Celebration of its Parent Trust, PTVA.
- Dr. Purohit informed the committee members that AQAR for the academic year 2018-19 shall be submitted to NAAC shortly.
