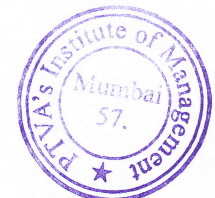


**#Note for Reserved Category students:**

2. As per the Maharashtra Govt. GR No. TEM-2018/PK35/TE-4 dated 31.03.2018 & GR No. EBC-2017/PK27/Shikshan dated 01.01.2018 student belong to DT/VJ, NT, OBC & SBC category are eligible for Freeship only if their annual family income is less than or equals to Rs.8,00,000/- (Rupees Eight Lakhs only).
