## Minutes of the IQAC meeting held online on Friday, May 15, 2020 at 4:30 pm


- Minutes of the IQAC meeting held on January 10, 2020 were confirmed.
- Dr. Tejashree Deshmukh apprised the members about how PTVAIM completed the academic
  and exam related work of the on-going semesters (except final semesters) during the lockdown
  following the guidelines received from the UGC, AICTE and University of Mumbai.
- Dr. Harish Kumar Purohit informed the members that the University of Mumbai has formed a
  committee to work on the exam related issues to be tackled and important decisions regarding
  the same which need to be taken during the lockdown.
- Dr. Sucheta Pawar presented the COEI activities including the on-going pre-incubation program and MIC as well as IIC activities conducted and planned.
- She informed the members about the survey based webinar to be conducted by COEI at the last week of May 2020.
- Dr.Sucheta shall be sending the survey related questionnaire to the IQAC members for approval immediately.
- COEI plans for A.Y. 2020-21 including an exclusive program for schools and Rendezvous with Torch Bearers were discussed.
- PTVAIM has applied for MBA in Innovation, Entrepreneurship & Venture Development to the AICTE.
- COEI team to create a database of the students attending various webinars during the lockdown.
- COEI received two STARS for IIC activities from MIC for the academic year 2018-19.
- Research paper of Dr. Tejashree Deshmukh co-authored with Mr.Jigar Patel and another one of Mrs. Trupti Gupte were published in SCOPUS journals.
- 4 research papers jointly written by the faculty members and students of PTVAIM were published in UGC CARE approved journal.
- Quality research work done by the faculty members of PTVAIM to be shared with the industry
  experts associated with our Institute to explore the possibility of getting consultancy projects
  from the Industry related to the research areas.
- Dr.Sucheta Pawar, Mrs. Shalini Kakkar, Mrs. Trupti Gupte, Mr. Abhishek Deokule, Mrs. Aparana Patil and Mr. Ajinkya Kumawat mentored 77 MMS students regarding "Research".
- 2 minor paid research project proposals submitted by Mr. Jigar Patel and Mrs. Manali Patil as
  well as by CA Rajul Murudkar and Dr.CA Ajit Joshi were approved by the University of
  Mumbai. The deadline to submit these project reports is usually the month of September of the
  Academic Year. However, this time due to lockdown the deadline is expected to get extended.
- Dr. Sucheta Pawar apprised the members of project SAKSHAM undertaken by PTVAIM in association with Learning Space Foundation and Amhi Udyogini to provide livelihood opportunities for the women of rural areas of Palghar district.
- Besides manufacturing the cloth bags, SAKSHAM team shall concentrate on making facial masks required during COVID 19.
- SAKSHAM team shall explore the possibilities of applying for the benefits declared by Hon'ble Union Finance Minister, Mrs. Nirmala Sitharaman on May 13, 2020 with respect to the economic packages for KUTIR UDYOG.
- CA Rajul Murudkar apprised the members about Bazaarhaat, the Students' Skill Development Programme' held on January 25, 2020. Bazaarhaat was a fully sponsored event. CA Rajul Murudkar on behalf of the faculty team working for this event thanked Mr. Mohan Tanksale
