Applications are invited from eligible candidates for admission Against CAP vacancies and any cancellations arising after the completion of all CAP rounds, to the Two-Year Full-Time Master of Management Studies (M.M.S.) program (affiliated to the University of Mumbai and approved by the AICTE) for the Academic Year 2026-2027 [Batch 2026-2028].

Eligibility – Strictly as per the guidelines and regulations prescribed by the Admission Regulating Authority (ARA), CET Cell, and DTE (Government of Maharashtra).

Applicants must have appeared for a valid entrance examination and should be registered with the State CET Cell, having completed the document verification process through either E-Scrutiny or Physical Scrutiny. Candidates applying under the All-India Seats and PH category are also eligible to apply. Admission for these seats will be subject to the availability of seats as per the rules laid down by the State CET Cell / ARA.
